## TYPES OF FINANCIAL AID .....

Financial aid is federal, state, institutional and private monies used to assist eligible students in funding their education. Financial aid can be scholarships, grants, loans, tuition waivers, and student employment.

### SCHOLARSHIPS

Scholarships are funds that do not have to be repaid. They are awarded based on a student meeting certain eligibility criteria. Scholarships are provided by many sources both on and off campus.

### GRANTS

Grants are funds that do not have to be repaid. They are available to students who meet financial need criteria. (See how to determine need, page 6)

### LOANS

Loans allow students to borrow money for educational expenses. Loans are subject to interest rates and must be repaid.

### STUDENT EMPLOYMENT AND WORK STUDY

Student employment helps students pay for college while gaining work experience. Work study is available for students who meet financial need criteria, but it is not required for most student jobs at Texas A&M University.

### TUITION WAIVERS

Non-resident tuition waivers allow students who are not Texas residents to pay the fees and charges required of students from Texas. These waivers are available to students awarded a competitive University scholarship of a minimum dollar amount.

### AGGIE ASSURANCE PROGRAM

Texas A&M University is committed to assisting low and middle income students through the Aggie Assurance program. Aggie Assurance helps students with a family income of \$60,000 or less by ensuring that eligible students have enough scholarships and grants to pay for tuition.

Beginning with academic year 2021-2022, we expanded our Aggie Assurance commitment to provide tuition support grants for first-time freshman and transfer students whose family income is greater than \$60,000 but no more than \$130,000. The amount of the tuition support grants will vary based on income and financial need. Tuition support grants will not cover full tuition.





## COST OF ATTENDANCE

Your estimated cost of attendance (COA) doesn't cover just your college tuition and fees; it takes into account your basic living expenses, too. So think about this: it is going to cost you the same amount to live for the next few years whether you're in college or not.

When comparing financial aid packages from other schools, make sure you are comparing the total cost for attending that school, not just the total financial aid awarded.

## CALCULATING YOUR NET COST .....

Use Texas A&M's cost of attendance then subtract all grants and scholarships you have been offered. This will determine your net cost.

### NET COST

Net cost is calculated to assist you and/or your family in determining the cost of school and any funding that may need to be repaid. Refer to the College Financing Plan in your Financial Aid Offer Letter, located on the Awards page in the Financial Aid Portal, for more information on net cost. Students and possibly their parents may borrow from various student loan programs to help meet the total cost of educational expenses.

# APPLYING FOR AID .....

## FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA)

Complete the FAFSA online at [studentaid.gov/h/apply-for-aid/fafsa](https://studentaid.gov/h/apply-for-aid/fafsa). The FAFSA is available October 1. We recommend applying as early as possible. By completing the FAFSA, you are applying for federal, state and institutional aid. This includes grants, loans, and work study. The school code for TAMU is 003632.

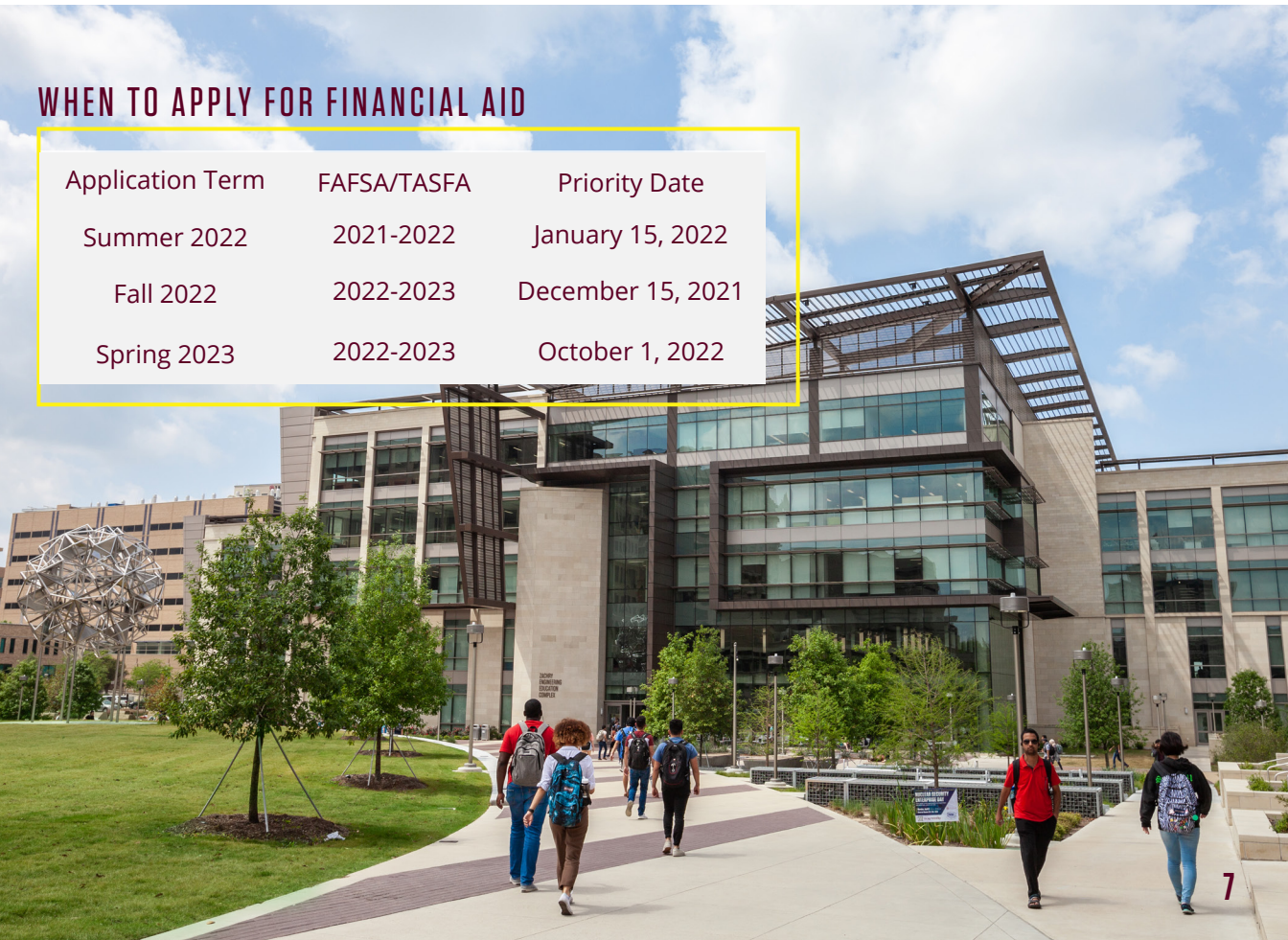
The FSA ID (a username and password) must be set up to log in to certain U.S. Department of Education websites. Your FSA ID confirms your identity when you access your financial aid information and is used to electronically sign Federal Student Aid documents. If you do not already have a FSA ID, you can create one when logging in to [studentaid.gov/h/apply-for-aid/fafsa](https://studentaid.gov/h/apply-for-aid/fafsa).

## TEXAS APPLICATION FOR STATE FINANCIAL AID (TASFA)

If you are not eligible to complete the FAFSA because of citizenship or visa status, but you are eligible to be classified as a Texas resident for tuition purposes, you may apply for state financial aid through the TASFA. You must complete the TASFA to be considered for many scholarships, grants, and loans. All supporting documentation must be submitted before a TASFA is considered complete and will be processed. Texas A&M University uses an online version of the TASFA. Information on how to access the application is available at [financialaid.tamu.edu](https://financialaid.tamu.edu).

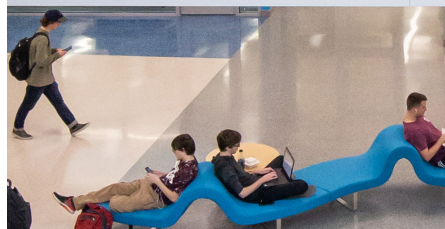
# WHAT IS NEEDED TO COMPLETE YOUR 2022-2023 FAFSA/TASFA

You (and your parent(s) or spouse) will need information from the 2020 tax return you filed with the Internal Revenue Service in order to apply for financial aid.

**IMPORTANT:** Use the IRS Data Retrieval tool when completing the FAFSA. This tool allows you to automatically transfer IRS tax data into your FAFSA, which makes the FAFSA easier to complete.

To complete your FAFSA/TASFA you will need:

- 1 | Social Security Number**  
Be sure it is correct (For FAFSA only)
- 2 | Driver License Number**  
If applicable (For FAFSA only)
- 3 | 2020 W-2 Forms**  
And any other records of money earned
- 4 | 2020 Federal Income Tax Return**  
You and your spouse's if you are married
  - IRS 1040 and any completed schedules (i.e., Schedule 1, 2, and/or 3)
  - Foreign tax return or tax return for Puerto Rico, Guam, American Samoa, the U.S. Virgin Islands, the Marshall Islands, the Federal States of Micronesia or Palau
- 5 | Your Parents' 2020 Federal Income Tax Return**  
If you are a dependent student
- 6 | 2020 Untaxed Income Records**  
Child support received and/or worker's compensation
- 7 | Current bank statements, current business and investment information, business and farm net worth, stock, bond and other investment records**
- 8 | Alien registration or permanent resident card**  
If you are not a U.S. citizen (For FAFSA only)







## AFTER APPLYING .....

### DETERMINING YOUR FINANCIAL NEED

Your Expected Family Contribution (EFC) is the amount that you and your parent(s) are expected to provide toward your educational costs from a combination of income, savings, or non-need-based loans. The EFC is calculated from the information you (and your parents/spouse) report on your FAFSA/TASFA. Financial need is the basis for most financial aid eligibility.

### PROCESSING YOUR FINANCIAL AID

Once we receive the results from your FAFSA/TASFA, we will offer you financial aid for the academic year (Fall/Spring). If we ask you to provide additional documentation, all requested documents must be received before your aid is paid. All offers are made on a first-come, first-served basis. Once you have received your offer letter, log on to the Howdy Portal at [howdy.tamu.edu](http://howdy.tamu.edu). Click on the Financial Aid icon and enter the Financial Aid Portal to accept/reduce/decline your aid. Accepting your financial aid does not confirm your admission to Texas A&M.

### HOW TO REPORT OUTSIDE SCHOLARSHIPS AND OTHER RESOURCES

If you are the recipient of scholarships or other resources (from a source other than Texas A&M University), you must report those awards to our office as soon as possible.

- To report an award from an outside source, please click on the “Report Outside Scholarships and Resources” link on the Status page in the Financial Aid Portal.
- Mail scholarship checks you receive to Scholarships & Financial Aid.
- The Donor Form is to be used by donors to inform our office about how they would like us to distribute the scholarship funds they are providing for you. This form can be found online at [scholarships.tamu.edu](http://scholarships.tamu.edu).
- An adjustment to your financial aid offer may be necessary to maintain your eligibility.
- You may be required to repay financial aid you have already received.
- Unless your scholarship check has specific instructions from the donor, it is our policy to divide all scholarships of \$1,000 or more into two equal payments to be paid at the beginning of each semester (Fall and Spring). This will help you pay your tuition, fees or other expenses.

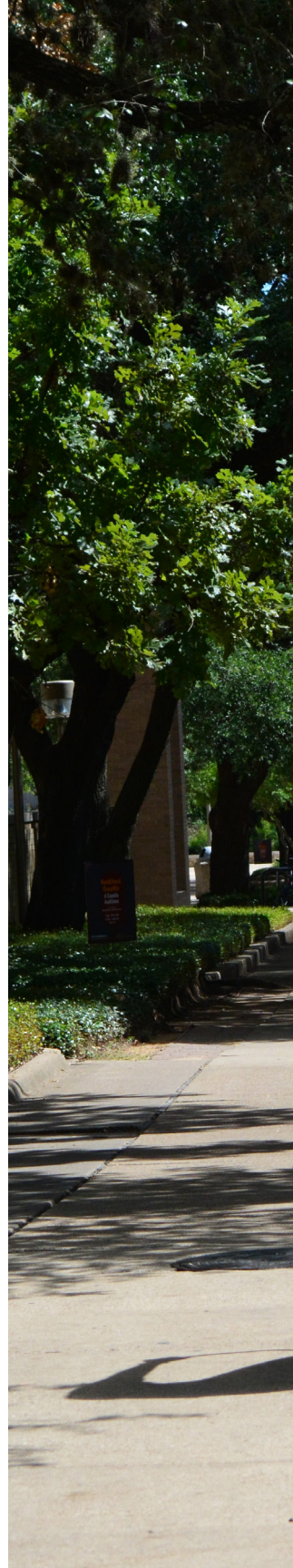

## MORE WAYS TO PAY .....

### Emergency Tuition and Fees Loan

This loan helps you with temporary assistance to pay tuition and required fees by the tuition deadline. It must be repaid in full within 90 days during the fall and spring semester and within 30 days during the summer term. Emergency Tuition and Fees Loans have a simple annual interest rate of 5%. In addition, a \$10 processing charge will be assessed. This application is available at [financialaid.tamu.edu](http://financialaid.tamu.edu).

### FEDERAL DIRECT PARENT LOAN (PLUS)

The Federal Direct Parent Loan (PLUS) is available to the parents of dependent undergraduate students. The parent may borrow only up to the cost of attendance (minus any other financial aid). An origination fee of 4.228%\* is charged upon disbursement. All funds are received electronically and are posted to the student's billing account to pay university authorized tuition and fees. Completion of the FAFSA is required. You can find more information about the PLUS loan online at [financialaid.tamu.edu](http://financialaid.tamu.edu).

### ALTERNATIVE LOANS

Another option to assist with financing an education is an alternative loan through a private lending institution. These loans should be used after other options have been exhausted. Carefully compare lenders and interest rates.

Resources to help you compare alternative loans are available online at [financialaid.tamu.edu](http://financialaid.tamu.edu). The choice of lender is yours.

### SHORT-TERM LOANS

Scholarships & Financial Aid offers short-term loans to assist students with temporary financial difficulties. You can borrow up to \$1,500 for eligible expenses, with repayment within a year. Short-term loans have a simple annual interest rate of 8%. In addition, there is a \$10 processing charge. This application is available at [financialaid.tamu.edu](http://financialaid.tamu.edu).

# SCHOLARSHIPS

Students apply for all university-level incoming freshman scholarships through the ApplyTexas or the Coalition application. Students should complete the admissions and scholarship sections, all required essays and the Self-Reported Academic Record (SRAR). Please note the scholarship deadline is December 1.

Your grades are only one of many considerations in the review process. Consideration is given to academic achievement in a college preparatory curriculum within the context of a student's academic environment and the Self Reported Academic Record (SRAR). Additional factors for selection include, but are not limited to, leadership, community service, special talents, first generation college status, and academic achievement under difficult circumstances. # SCHOLARSHIP PROGRAMS

## BROWN FOUNDATION SCHOLARSHIP PROGRAM

The Craig & Galen Brown Foundation awards scholarships to highest-achieving, well rounded high school seniors, state and nationwide, who have attained National Merit Semifinalist/Finalist status. Nominees must pursue Engineering, Science, Business or other STEM majors. Highest academic achievements, participation in school organizations, community service, leadership and people skills are characteristic of Brown Scholar applicants.

Brown Scholars are eligible for: Houston Methodist Research Institute Summer Internships, Bray International Global Summer Internships, and the Memorial Student Center Honors Freshman Leadership Seminar in Italy. Eligible nominees are forwarded to the Craig and Galen Brown Foundation for final selection with personal interviews.

### To be eligible, students must:

- Complete both the admissions and scholarship sections of the ApplyTexas or Coalition application, all required essays, and the SRAR by December 1
- Be named a National Merit Semifinalist/Finalist
- Apply to the University Honors Program, Brown Engineering Honors Program, or Mays Business Honors Program by December 1
- Be admitted and enroll full-time at Texas A&M-College Station for the fall semester after high school graduation

## CENTURY SCHOLARS PROGRAM

The Century Scholars Program is a partnership between Texas A&M University and participating Texas high schools to increase the number of enrolled students from under-represented high schools. Students selected as Century Scholars are awarded \$20,000 over four years, as well as a \$1,000 study abroad stipend.

### To be eligible, students must:

- Graduate from a participating high school in the Central Texas, Dallas/Fort Worth, El Paso, Houston, Laredo, Rio Grande Valley, and San Antonio areas (visit [scholarships.tamu.edu](http://scholarships.tamu.edu) for a list of schools)
- Complete both the admissions and scholarship sections of the application, all required essays, and the SRAR by December 1
- Be admitted and enroll full-time at Texas A&M-College Station for the fall semester after high school graduation

## GREATER TEXAS FOUNDATION AGGIE SCHOLARS PROGRAM

The Greater Texas Foundation (GTF) Aggie Scholars Program provides financial and educational support to selected Texas Early College High School graduates who are admitted to and attend Texas A&M. The GTF Aggie Scholars Program fosters a smooth transition from high school to college and provides the resources necessary to be successful in college. Participants benefit from academic guidance from GTF-dedicated advisors, peer mentoring and renewable scholarships.

GTF Aggie Scholars participate in a learning community and peer-mentorship programs designed specifically to ensure student retention and success. To be considered for scholarships, students must complete both the admission and scholarship sections of the Apply Texas or Coalition application, all required essays, and the SRAR by December 1.

## REGENTS' SCHOLARS PROGRAM

The Regents' Scholars Program was designed specifically for first-generation college students for up to \$24,000 over four years to pay for college based upon need as determined by the Free Application for Federal Student Aid (FAFSA) or Texas Application for State Financial Aid (TASFA). The program includes the support of a success program, specific orientation, and living on campus during the first year.

### To be eligible, students must:

- Identify on their admissions application that neither biological nor stepparent have a bachelor's degree
- Have a family income of less than \$40,000 per year as verified by the FAFSA or TASFA
- Be admitted and enroll full-time at Texas A&M University-College Station for the fall as a first-time freshman

NOTE: These scholarships will be awarded on a first-come, first-served basis as students complete their financial aid application (subject to change).

## TERRY FOUNDATION SCHOLARSHIP PROGRAM

The Terry Foundation is a Houston-based scholarship program founded to provide scholarships to outstanding Texas high school graduates for attendance at public colleges and universities within the state. Established in 1986 by Houston philanthropists Howard & Nancy Terry, the Foundation has assisted hundreds of Terry Scholars in meeting the founders' goal of helping young people to help themselves.

### To be eligible, students must:

- Complete both the admissions and scholarship sections of the ApplyTexas or Coalition application, all required essays, and the SRAR by December 1
- Be admitted and enroll full-time at Texas A&M-College Station for the fall as first-time freshman for the fall semester after high school graduation
- Participate in required interviews for finalists
- Demonstrate financial need by submitting the FAFSA

## ADDITIONAL SCHOLARSHIP OPPORTUNITIES

There are over 100 Aggie Mothers' Clubs in the United States. The purpose of the Aggie Mothers' Club is to contribute in many ways to the comfort and welfare of students. ### CORPS OF CADETS SCHOLARSHIPS

The Corps of Cadets is committed to offering students a wide range of opportunities to learn, succeed and excel. There are more than 1,800 Corps scholarships available. Scholarships range in value from \$1,200 - \$5,000 per year and with no military obligation. Corps scholarships are awarded based on merit

and/or need, with many reserved for students entering the Corps as freshman cadets. In addition, most Corps scholarships assist in qualifying out-of-state residents to pay tuition at the in-state rate. Visit [corps.tamu.edu/scholarships](https://corps.tamu.edu/scholarships) for more information.

## FOUNDATION EXCELLENCE AWARD

The Foundation Excellence Award helps recruit and retain outstanding undergraduates from historically disadvantaged groups who often face significant economic or educational hurdles. Each award provides up to \$2,000 per year for up to four years. The Texas A&M Foundation is an independent, nonprofit corporation that raises private gifts in support of Texas A&M University. To apply, you must complete both the admissions and scholarship sections of the ApplyTexas or Coalition application including all required essays and the SRAR by December 1.

## HIGHEST RANKING HIGH SCHOOL GRADUATE (VALEDICTORIAN) TUITION EXEMPTION

The highest ranking graduate from Texas high schools accredited by the Texas Education Agency are entitled to a tuition exemption during their freshman year at Texas A&M University. Visit [scholarships.tamu.edu](https://scholarships.tamu.edu) for more information.

# SCHOLARSHIP BENEFITS

## OUT-OF-STATE TUITION WAIVERS

Students from outside the state of Texas receiving competitively awarded scholarships administered by Texas A&M University at a minimum dollar amount, set by the University, will pay tuition at the same rate as a resident of Texas for each academic year the scholarship is received.

- The value of this waiver is approximately \$27,000 per year
- Renewed each academic year as long as the student remains eligible for the scholarship(s) that granted them the non-resident tuition waiver for that academic year
- Must remain in good standing with the University and meet all other eligibility requirements

## STUDY ABROAD STIPEND

Students who have completed at least one academic year at Texas A&M University and who receive an Academic or Achievement Scholarship are eligible to receive a \$1,000 Study Abroad Scholarship Stipend for participation in an approved Texas A&M study abroad program.

- Scholarship stipend must be utilized prior to graduation
- Students are only eligible for one stipend throughout their academic career
- Students must be meeting all renewal criteria of their Academic or Achievement Scholarship\*
- Only study abroad programs recognized by the Texas A&M University Study Abroad Office are eligible for this stipend
- Enrollment requirements must be met

# NATIONAL RECOGNITION SCHOLARSHIPS

## NATIONAL MERIT® OPPORTUNITIES

Texas A&M University provides numerous scholarship opportunities to students who progress in nationwide competitions sponsored by the National Merit Scholarship Corporation (NMSC) or The College Board. National Merit Finalists who select Texas A&M University as their first choice institution are guaranteed to be offered the awards listed in the table. The scholarships listed below will be in addition to any other scholarships from our office, individual colleges or departments at Texas A&M or from other outside donors. For out-of-state students, the value of the scholarship package could increase due to the non-resident tuition waiver, currently valued at approximately \$27,000 per year.

## NATIONAL RECOGNITION OPPORTUNITIES

Students who are recognized as National Scholars by The College Board are guaranteed scholarships over four years.

### To receive this guarantee:

- Scholar must be designated as a National Scholar
- Admitted to and enrolled full-time at Texas A&M University-College Station
- A spring high school graduate and a fall incoming freshman.

In addition, most National Scholars are eligible to compete for other scholarships offered by Scholarships & Financial Aid or individual colleges/departments at Texas A&M. National Scholars who are recognized in both National Merit and National Scholar competitions will receive the National Merit offers.

### National Recognition Scholars Package over Four Years:

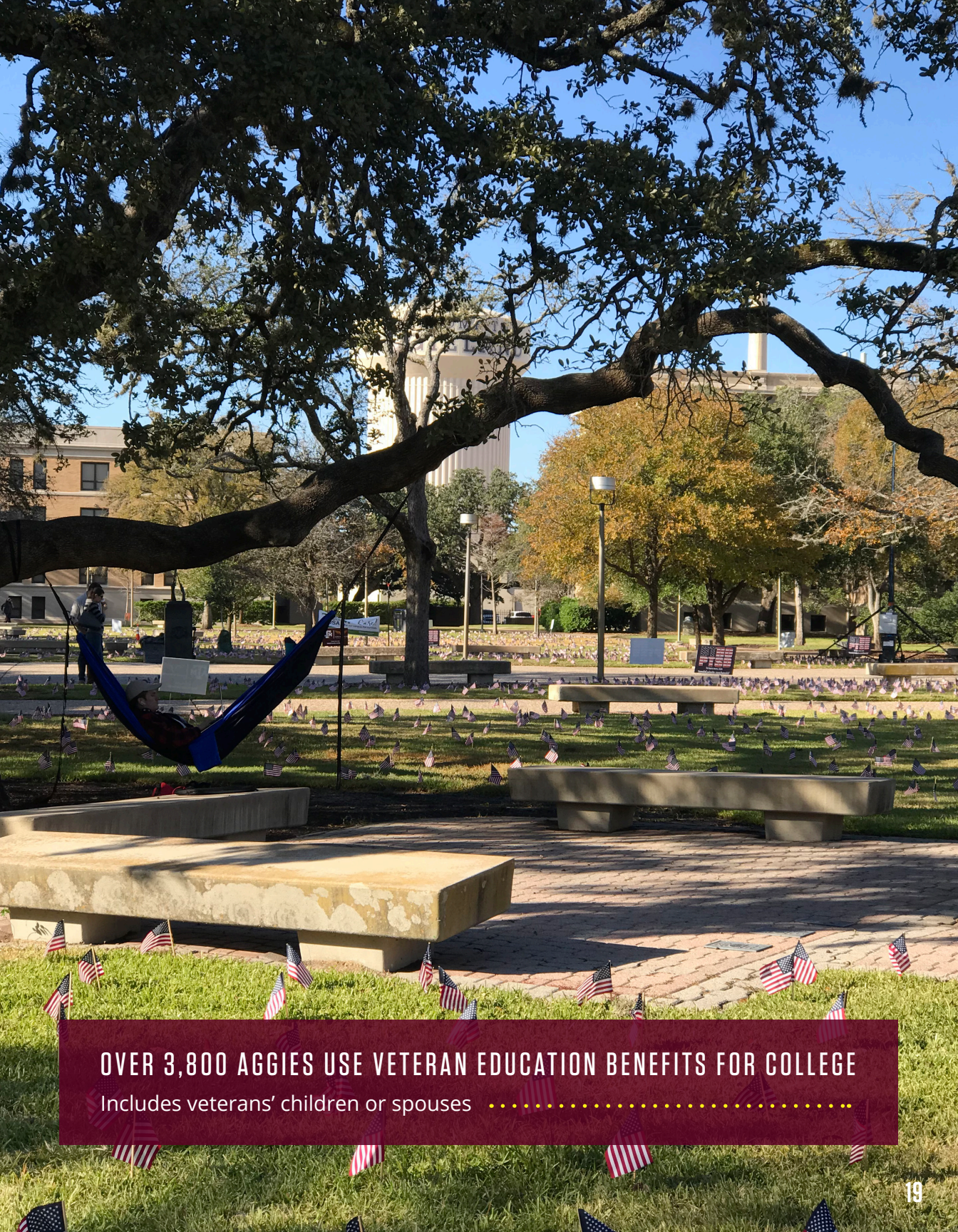

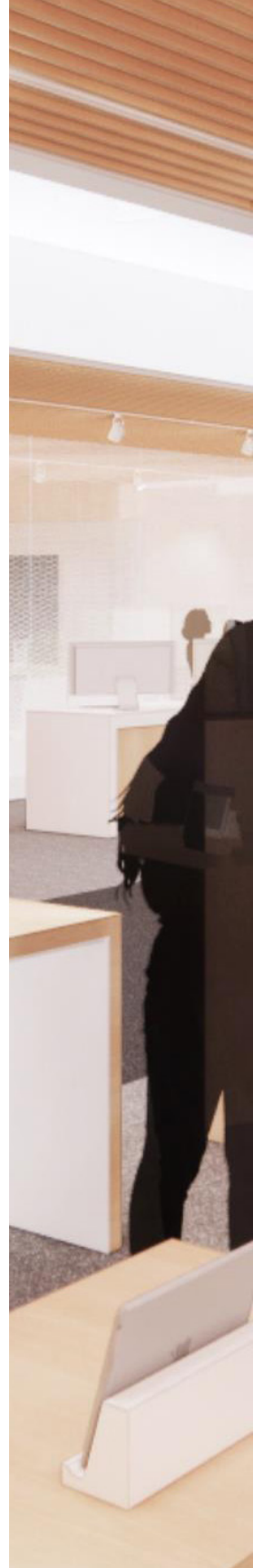
